## **Thank You Indian Mountain Voters for Your Support in the May 6<sup>th</sup> Election!**

Below is the platform that we (Fred, Susan and Glenn) ran on. We offer it again to remind all IM taxpayers of where we sit and will try to do for you in the next four years.

1. Respect and treat fairly all IM property owners: full-time and part-time residents, seasonal residents, and those who do not have a residence in IM.
2. Place a priority on the maintenance and upgrade of existing IMRPD recreation facilities (e.g., golf course, trails, signs, and IM parklands).
3. Restore a collaborative and productive working relationship with IMPOA.
4. Build a website that is attractive, easy to use, up to date, and contains important information about elections, meeting agendas, minutes, financials, plans, and key decisions.
5. Post the draft minutes and financials on the web within 30 days of each Board meeting.
6. Hold the regular Board meetings one Saturday every other month in order to save money and to make it easier for IM property owners to attend.
7. Host a summer picnic for IM families at the Picnic Pavilion.
8. Host a summertime “brainstorming” open house for IM property to share your opinions, concerns and priorities with the Board.
9. Consider a tax decrease by developing a 4-year plan and budget for the IMRPD.
