Public Comment: Lengthy discussion (45 minutes) of Water situation with IMC; it was apparent by the voices and words that people are frustrated, angry, feeling threatened by lien and loss of property values; the words extortion and fraud were used; several owners said they bought their property from IMC and the price reflected access to well permit which requires a court approved water augmentation plan with associated water rights; many comments made in opposition to IMC and none in support.

Roger Mattson, IMPOA, discussed various issues such as speeding, livestock grazing, trailers on properties, and membership. IMPOA is seeking volunteers to help send out its community wide update and membership recruitment. Membership is at an all-time high.
