• Water Update

James Ingalls asked to speak, he asked the IMMD board to not proceed with litigation, that doing so was a waste of the taxpayer's money. He stated that the Appellate Court ruling, is the ruling that stays, and that individuals would have to go to water court to get off of the Ind. Mtn. water aug plan.

There were numerous heated comments from the audience, regarding his trustworthiness and fairness. He stated that he and his new partner Owen Smith want to keep the costs down, and he said let's come up with a price that is affordable for everyone. He stated that he was offering a guaranteed fixed rate for a 10 year plan, yet when asked what happens to my plan at the end of ten years, he responded that he didn't know, he may not even own it then....He finished by saying that options are getting tighter and tighter for his plan. The entire meeting was recorded by Jeremy Turner.

**Motion:** The Board agrees to move forward with the IMMD/IMC(aka)BSW litigation by appealing to the Colorado Supreme Court. We recognize that in the pendency of a decision, that Judge Groomes ruling stating IMC can only charge for actual and reasonable operation costs will stand, and that the Board will concurrently begin work to develop alternatives for the Indian Mountain community to secure water services for their homes.
