## • Water Update:

Glenn reported that the third and final document to the Supreme Court was submitted by IMMD on Thursday Dec. 8, 2016. The Supreme Court will first make a decision as to the merits of considering the IMMD appeal. If they agree there is merit, a court date would be set. This process could well take months.

In the meantime, a variety of alternatives for water services are being explored.

The Board and guests discussed the on-going litigation including a number of questions and worthy suggestions. One resident reported on their phone conversation with District Engineer Dave Nettles---very interesting.

#### Fire District:

Gene Nagel was invited to provide an update; the burn ban has been lifted; no date has been set to burn the IM Burn Pit and not likely in 2016; there was a small fire behind the shooting range apparently caused by use of ammo with full metal jackets. The Board discussed need to include information in the forthcoming newsletter.
