Business Manager Report-Samantha

- IMMD has received a safety grant of \$948---this is to be 50-50 matching monies used in 2017. Board discussed need for AED batteries and restocked CC first aid kit.
- July 4<sup>th</sup> tent has been reserved.

Maintenance Report---Charles

• Cattle have gotten into pasture golf course; lots of pies; he will ride the fenceline and see what the problem is.

### **Unfinished Business**

- Burn pit
  - Conditions still not good for burning; it would not be wise to add more slash to the pile; there is a chance we cannot open the pit this summer.
  - It was suggested that a community list of property owners willing to have people cut wood on the lot be assembled, or that people post a notice on Nextdoor or road sign; the next IM newsletter will address the topic.
- County-Wide Burn Ban System
  - In the past there was little coordination across the agencies about when and where there is a burn ban; new county-wide system will coordinate the fire districts, sheriff's office and Forest Service.
  - > It was also noted the importance of when people report fires that they be very descriptive

and accurate or else resources are sent searching for a fire in wrong locations or a fire which does not exist. Kudos offered to fire district.

- Chipping---Roger and IMPOA would like to resurrect the forest slash chipping program. More details to come.
- Noxious Weed program---Bret has communicated with the County Extension specialist about our noxious weeds; a site visit is planned; they provide spraying services on a cost share basis. More details to come.

### **New Business**

- Water Update---Glenn reported that good progress has been made on Water Service Program:
  - Inter-governmental agreement has been drafted
  - ➤ Grant application will be submitted April 20<sup>th</sup>
  - Accounting format has been developed
  - ➢ IM promotional piece has been drafted
  - ➢ WSP application form has been drafted
  - Meter installation and certification support is in place
  - > DWR has been consulted; second meeting planned

# *Motion:* The Board approves the submittal of our grant application to the PC L&WTF. *Unanimously approved*

The plan remains to announce the WSP program in May, accept 2017 applications in late May through July, sign IGA between HASP and IMMD in August/September, and formally launch the WSP on January 1, 2018.
