# THE DISTRICT

### THE SYSTEM

The Board of Directors is responsible for the operation and policies with respect to the District, in accordance with statutes and the service plan.

### IMPORTANT FEATURES OF THE BUDGET

The budget reflects revenue from property taxes, specific ownership taxes, interest income, and lottery revenue. The District anticipates the following capital/special projects:

- 1. Improvements to Facilities
- 2. Nature Trail Improvements at Indian Mountain
- 3. Natural Resource Management (Fire Mitigation)
- 4. Water Augmentation Management

## **BUDGETARY BASIS OF ACCOUNTING**

The budget for 2017 was prepared on a modified accrual basis of accounting. Revenues and expenditures recorded on a modified accrual basis.

### RESOLUTION TO SET MILL LEVIES Resolution #1 - 12/2016

A RESOLUTION LEVYING THE GENERAL PROPERTY TAXES FOR THE YEAR 2017 TO HELP DEFRAY THE COST OF GOVERNMENT FOR THE INDIAN MOUNTAIN METROPOLITAN DISTRICT, PARK COUNTY, COLORADO, FOR THE 2017 BUDGET YEAR.

WHEREAS, The amount of money necessary to balance the budget for the general operating purposes is \$207,315. and

WHEREAS, The 2016 valuation for assessment for the District, as certified by the County Assessor, is \$19,383,010

NOW, THEREFORE, be it resolved by the Board of Directors of the Indian Mountain Metropolitan District, Park County, Colorado.

Section 1. That for the purpose of meeting all the general operating expenses of the District during the 2017 budget year, that is a tax of 6.943 mills upon each dollar of the total valuation for assessment of all taxable property within the District for the year 2017:

Section 2. That the Secretary of the District is hereby authorized and directed to immediately certify to the County Commissioners of Park County, Colorado, the mill levies for the District as herein above determined and set.
