- Contractor will identify wildfire hazard, values at risk, and priority areas for mitigation in Indian Mountain Park which consists of areas of dense forest with heavy down dead fuels. Contractor will recommend to and discuss with the Board of Directors of Indian Mountain which areas of Indian Mountain Park should be prioritized in order to most effectively reduce fire danger and promote forest health.
- Present a plan to dispose of forest slash, e.g. removal to off-site location, curtain burner, mastication, chipping.
- Present a plan for the use of useable forest products generated, e.g. fire wood piles for use by Indian Mountain Residents, or offer a discount for contractor taking useable forest products, etc.
- Present a plan for forest access beyond the available two-tracks (see attached map).
- Work hours will not begin before 8:00 A.M. or extend past 6:00 P.M. to minimize noise pollution for Indian Mountain residents.
- The Indian Mountain Board feels that there currently is no need to do any mitigation in the Disk Golf Course or around the Indian Mountain Buildings and would prefer to keep equipment away from the Disk Golf Course (see map).






Exhibit A – Maps of Indian Mountain Park

Indian Mountain Park - 2-1/2 acre grid lines










